

#### **CLYDE WILLIAM KAYSER, II**

Clyde William Kayser II was born on April 26, 1947 in Dayton, Ohio to Clyde Hartman Kayser Jr. and Viola Berger Kayser. He graduated from Stivers High School in June 1965 and enrolled in Capital University in Columbus, Ohio, graduating in 1969, receiving a Bachelor of Science Degree with a dual Chemistry/Mathematics major. In 1972 he enrolled at Wright State University in Dayton for post-graduate work, receiving a Master of Science Degree with emphasis in Analytical Chemistry in 1974. He also earned an Associate Degree in Electronics from Sinclair Community College in Dayton. Later he pursued advanced studies toward a Master's Degree in Environmental Engineering for the University of New Haven.

Upon graduation he was employed as a laboratory chemist at Bowser-Morner Testing Laboratories in Dayton, Ohio. This laboratory provided analytical support for many small foundries and pattern shops in southwest Ohio. It also provided adjunct laboratory assistance to the Air Force Institute of Technology stationed at Wright-Patterson Air Force Base in Fairborn. In 1976, he relocated to Connecticut to take a position as a Materials Engineer in the Process and Technology Laboratory at Avco Lycoming, later known as Textron Lycoming, in Stratford. Initially he worked in the Process Control Laboratory, analyzing incoming materials for specification compliance. in this position he helped develop analytical parameters for the proto-type of Perkin-Elmer first Graphite-Furnace Corporation's Atomic Absorption Spectrometer. Three years later he transferred to the Material and Process Technology Laboratory. In this position he was responsible for using Electron Microscopy to analyze atomic structures of hightemperature alloys and Scanning Electron Microscopy characterize failures in turbine blades. He also assisted Cameca Corporation in writing a translation of the French operations manual for their new Electron Microscope. He remained at Lycoming for nineteen years until the company closed in 1995. For the next three years he worked as a plating laboratory chemist at the Whyco

Chromium Company in Thomaston, and in August 1999, he accepted the position of Laboratory Manger at the Ansonia Copper and Brass Company. One of his first duties in this position was to make sure that the software operating the laboratory analysis and foundry casting operations was Y2K compliant. When this company decided to cease operation in June 2009, he finally retired.

Brother Kayser is a member of Hope Lutheran Church in Dayton, Ohio. On June 27, 1982 he was married to Alvina Jane (A. J.) West. They currently reside in Waterbury with their several cats.

While living in Ohio, Companion Kayser was active in Boy Scouting. As a boy he earned the rank of Eagle Scout and was presented with the Pro Deo et Patria religious award of the Lutheran Church. All four of his brothers did the same. As an adult he served as an Assistant Scout Master, Neighborhood Commissioner, District Commissioner and District Executive. While serving as Commissioner of Pioneer District, Miami Valley Council, he helped establish the first Scout Troop in America dedicated solely to serve disabled boys. He completed the Scouter's Key training and advanced Wood Badge Training and led an expedition to Philmont Scout Reservation in New Mexico. For two summers he was on the staff of Woodland Trails Scout Reservation at Camden, Ohio working on the lake front staff and serving as councilor for the Canoeing and the Rowing merit badges. In honor of his service to Scouting, in 1974 he was presented with the Miami Valley Council "Scouter of the Year" Award. He was also admitted to the Order of the Arrow camping honorary, where he attained the rank of Vigil Member, presided as Chief of the Fire for three years and performed as Methu, the witch doctor, for the initiation ceremony. Upon moving to Connecticut, Scouting was replaced with Masonry.

His other interests include stamp collecting, model railroading and sports.

### Masonic History

#### Symbolic Lodge:

Brother Kayser was raised a Master Mason in Federal Lodge No. 17 in Watertown, Connecticut on June 4, 1984. His father, a Past Master and forty year Secretary of Aero Lodge No. 648 of Dayton, Ohio, was a surprise visitor for his Master Mason Degree. The next year he was installed as Senior Steward, and progressed through the officer line, serving as Worshipful Master in 1990, the 200<sup>th</sup> Anniversary year of Federal Lodge. He has served as Secretary of the Lodge since 1991. In 1994 he affiliated as a dual member of Harmony Lodge No. 42 in Waterbury. In recognition of his service to the Lodge, in 2008 Most Worshipful Grand Master Robert Stika presented him with the Pierpont Edwards Medal. In 2021 he was presented with the Worshipful Brother Ashler Blakeslee Award for distinguished service to Federal Lodge.

#### **Royal Arch Masonry:**

Companion Kayser was exalted a Royal Arch Mason in Granite Chapter No. 36 in Thomaston on September 18, 1986. He served as an officer in various stations, eventually being installed as Most Excellent High Priest in 1993, an office he held until 1998, when Granite Chapter consolidated with Cyrus Chapter No. 45 in Torrington. He affiliated with Franklin Chapter No. 2 in New Haven on May 2, 1992, and served as Most Excellent High Priest in 1999 and 2000. Since 2012 he has served as Secretary of this Chapter. In 1992 Most Excellent Grand High Priest Steven Piner appointed him Right Excellent Grand Custodian of Capitular District Two, an office he held for four years. He was consecrated an Anointed High Priest in 1993 and presided as Excellent President in 1999. At the 1999 Grand Chapter Session, Most Excellent Grand High Priest Donald Murray presented him the Ephraim Kirby Citation for Distinguished Masonic Service, and in 2003 he was appointed Grand Representative to the Grand Chapter of Indiana. In 2011 he was awarded the General Grand Chapter Ritual Medal. In 2016 Most Excellent Companion Martin Ede appointed him as Right Excellent Grand Master of the Second Veil, and at the June 3, 2017

Annual Conclave he was presented with the General Grand Chapter Medal in Bronze. He was elected and installed Most Excellent Grand High Priest of the Grand Chapter of Royal Arch Masons of Connecticut on June 4, 2022..

#### **Royal and Select Masters:**

Companion Kayser was received and greeted a Select Master on October 26, 1991 in Buel Council No. 20 in Litchfield Connecticut. He served as Recorder of the Council from 1992-1998. On April 14, 1992 He affiliated with Harmony Council No. 8 in New Haven and served as Thrice Illustrious Master in 1993 and 1996. Since 2012 he has served as Recorder of this Council. In 1993 he was admitted to the Council of Anointed Kings and he was appointed Grand Representative to the Grand Council of Indiana in 1998. At the 1998 Grand Council Session, Most Puissant Grand Master Thurman Sharples presented him with the Knight of Ish Sodi Meritorious Service Award. In 1999 Most Puissant Grand Master Richard Eppler appointed him Grand Marshal, and in 2011 Most Puissant Grand Master Bruce Bellmore appointed him as Grand Sentinel to the officer line of The Most Puissant Grand Council of Royal and Select Masters of Connecticut. At the 2014 Grand Council Session Most Puissant Grand Master Charles McCollum awarded him with the Phillip J. Jones Distinguished Service Award, and in 2017 he presided as Most Puissant Grand Master of The Most Puissant Grand Council of Royal and Select Masters of Connecticut.

#### **Commandery of Knights Templar:**

Sir Knight Kayser was knighted on January 17, 1992 in New Haven Commandery No. 2 in New Haven. The next year he served as Assistant Recorder, and the following year joined the officer line as Junior Warden. He presided as Eminent Commander in 1997. Since serving as Commander he has been a director of the Order of the Temple. In 1998 he was received into the Knight Crusaders of the Cross where he presided as Knight Commander of the East in 2014. In 2002 he affiliated as a plural member of St. Elmo Commandery No. 9 in Meriden where in 2006-2007 he presided as

Eminent Commander. He currently serves as Recorder of both Commanderies. He is affiliated as a member of DeValois Commandery No. 16 in Vinyl Haven, Maine, and is also Grand Representative to the Grand Commandery of Ohio. At the 2006 Grand Commandery Session Right Eminent Sir Knight Edward Ham presented him with the Knight Templar Cross of Honor. In 2008 Right Eminent Grand Commander Bruce Bellmore appointed him as Grand Warder of the Grand Commandery of Connecticut, and in 2016 he presided as Right Eminent Grand Commander of the Grand Commandery of Knights Templar of Connecticut.

#### **Ancient Accepted Scottish Rite:**

Brother Kayser became a member of the Valley of Waterbury and Lafayette Consistory on May 5, 1986. In the Valley of Waterbury he presided as Thrice Potent Master of Doric Lodge of Perfection in 1995, Sovereign Prince of Ionic Council, Princes of Jerusalem in 1994, and Most Wise Master of Corinthian Chapter of Rose Croix in 1993. He served as Secretary of the Valley from 1996 until 2015. For his service to the Scottish Rite Brother Kayser was presented the Ill.. Arthur M. Brown (now the Fredrick H. Lorenson), 33°, Meritorious Service Award at the June 9, 1995 Council of Deliberation session. He was further honored on August 27, 1996 when he was coroneted a 33° Mason and created an Honorary Member of Supreme Council at the Supreme Council Session in Boston. In 1996 Brother Kayser was appointed Orator of Lafayette Consistory, and in May of 2004 he was installed to preside as Commander-in-Chief of the Consistory for two years. He is also a founding member of the Board of Governors of the Waterbury 32° Masonic Learning Center for Children.

#### **Other Masonic Affiliations:**

Sir Knight Kayser was initiated in Connecticut York Rite College No. 17 on June 19, 1993, served as Preeminent Governor in 2004, and on July 25, 1998 he was honored with the Order of the Purple Cross. On March 10, 1969, Brother Kayser was initiated in Connecticut Priory No. 28, Knights of the York Cross of Honour,

and served as Eminent Prior in 2008. He is also a member of the Royal Order of Scotland, Novum Aboracum Chapel No. 7 and Nutmeg Chapel No. 29, Order of Saint Thomas of Acon, where he presided over both as Worthy Master; Mohawk Council No. 28, Knight Masons, where he is a Past Excellent Chief; Apostle's Tabernacle No. XXVII, Holy Royal Arch Knight Templar Priests, were he is currently presiding as Very Eminent Preceptor; Connecticut College S.R.I.C.F.; Nathan Hale Council No. 78, Allied Mason Degrees, where he is currently Sovereign Master; and Good Will Chapter No. 112, Order of the Eastern Star, where he has served as Worthy Patron many times.

#### **ANNUAL SESSION**

The Annual Sessions of the Grand Chapter of Royal Arch Masons of Connecticut and The Most Puissant Grand Council of Royal and Select Masters were in the Courtyard by Marriott, 4 Sebethe Drive, in Cromwell, Connecticut on 2 and 3 June 2023.

#### **GRAND BANQUET**

The combined Annual Banquet in honor of Most Excellent Grand High Priest Clyde W. Kayser II and Most Puissant Grand Master James S. McNeely IV began with a social hour at 5:30 pm followed by the Banquet at 6:30 pm. In attendance were approximately 80 Companions, guests and ladies.

RI Grand Recorder William L. Miller called the audience to rise and welcome the Head Table as they entered and were introduced. Companions Kayser and McNeely each then welcomed all present, and then called upon Companion Bruce R. Bellmore, Assistant Grand Chaplain of the Grand Chapter, for an invocation. All present then joined in the Pledge of Allegiance to the U.S. Flag, followed by singing the "Star Spangled Banner" and "O Canada".

As the meal was being served, the presiding officers introduced the Head Table and various invited guests. ### **DELIBERATIONS OF THE GRAND CHAPTER**

#### **OFFICER REPORTS**

#### **REPORT and ADDRESS of the GRAND HIGH PRIEST**

#### Greetings Companions,

It is with much pleasure that I welcome you to this Twohundredth-twenty-fifth Annual Convocation of the Grand Chapter of Connecticut. I extend a special greeting to the Companions of my two Chapters, Franklin-Halleck Chapter No. 2 and Cyrus-Meridian Chapter No. 15. I thank you for covering for me in my absences this past year as I fulfilled my Grand Chapter obligations.

I welcome Companion David W. Schuler, Most Excellent Northeast Regional Deputy Grand High Priest. We have known each other for many years as we have traveled through the Grand York Rite lines in Connecticut and Vermont.

I welcome Companion Teko A. Foly, Right Excellent General Grand King to this session. I have intently listened to your messages at several of the Grand Sessions I have attended. Your concerns for the future of Capitular Masonry are genuine, and I am looking forward to your August ascension to Most Excellent General Grand High Priest.

I welcome Companion and Brother Matthew F. Griffin, Right Worshipful Grand Senior Steward and personal representative of Brother Joseph J. Porco, Most Worshipful Grand Master of the Grand Lodge, A.F. & A.M of Connecticut to this session. I too have known you for several years, and I am excited to hear about the Grand Master's "Blue Wave" membership retention program and how it can be beneficial to the York Rite.

Fifteen years ago Most Excellent Companion Bruce Bellmore appointed me Eminent Grand Warder in his Grand Commandery line, and three years later he appointed me Illustrious Grand Sentinel in his Grand Council line. I progressed through those lines to serve as Right Eminent Grand Commander in 2016 and Most Puissant

Grand Master in 2017. Most Excellent Companion Bellmore recommended me to Most Excellent Companion Martin Ede as a good fit for vacancy at Grand Master of the 2<sup>nd</sup> Veil in his Grand Chapter line. Today, as I address you as Most Excellent Grand High Priest, it is the culmination of my fifteen-year odyssey through the three York Rite Grand lines. It has been a pleasurable journey and I feel I am much better off for having taken it.

However, this has been a difficult year for Lady A.J. and me. Last year after three years of COVID-induced delays, my Lady A. J. finally was scheduled for much needed knee replacement surgeries. On March 15<sup>th</sup> her left knee was replaced and on August 9<sup>th</sup> the right one was done. Her surgeon was Dr. Robert Kennon of Orthopaedics New England, one of the foremost replacement surgeons is the Northeast. He is the son-in-law of Dr. Kristpas Keggi who was the inventor of both the knee and anterior hip replacement surgeries. Lady A. J. was initially scheduled to have her rehabilitation at the newly opened Orthopedic Rehab Center at Masonicare. However because of the fear of infections, Dr. Kennon would not release her to any rehab center, so she had to do it at home. Our two-story house was not conducive to a rapid recovery, so she did her rehabilitation at her Brother's one-story house in Wolcott. That meant for several weeks I was making two to four trips a day back and forth between the two houses to feed our cats and take her to doctor's visits and physical therapy. Thankfully we are pretty much through with the recovery process.

#### <u>NECROLOGY</u>

Years ago a Masonic Brother told me that when you had a sad or disappointing report to give it should always be preceded by either a reading of Scripture or a poem:

> "Hands round, yet faithful Brotherhood, The bright fraternal chain, We part upon the Square below, To meet in heaven again!

We will now pause in our deliberations while Companion William E. Weisert II, Right Excellent Grand Chaplain, leads us in a moment of prayer for our departed Companions.

#### **DISPENSATIONS**

During the year, I issued three dispensations, numbered 579 through 581:

**579** – Cyrus-Meridian Chapter No. 15 October 16, 2022 At the October 13, 2022 Stated Convocation of Cyrus-Meridian Chapter No. 15, the Companions finding the need to relocate the Chapter to a new location voted to request a dispensation to move their paraphernalia to the new location whenever it was determined. This request being consistent with the Rules and Regulations of the Grand Chapter, I granted the dispensation.

**580** – Cyrus-Meridian Chapter No. 15 November 12, 2022 At the November 10, 2022 Stated Convocation of Cyrus-Meridian Chapter No. 15, the Companions voted to request a dispensation to hold their December 08, 2022 Stated Convocation at the Danbury Masonic Temple, 337 Main Street, Danbury. Connecticut. This dispensation was further amended for the Chapter to hold by dispensation all future Stated Convocations on the second Thursday in Danbury until a bylaws change was approved by the Grand Chapter Bylaws Committee.

**581** – Columbia Chapter No. 31 February 22, 2023 At the February 03, 2023 Stated Convocation, Columbia Chapter No. 31 voted to request a dispensation to move their April 07, 2023 Stated Convocation to April 14, 2023. The reason for this request was that April 07<sup>th</sup> was Good Friday, and several of the Companions had religious commitments that evening. This request was received from Companion Patrick Kilby, Secretary, via e-mail – February 20, 2023

In April I received a request from Franklin-Halleck Chapter 2 for a dispensation to hold their annual meeting the week after their Stated Convocation, because they did not have a quorum in attendance on the regular meeting night. I verbally issued the dispensation, but upon thinking it out, I realized that it was not necessary to issue a dispensation for that reason, so I never officially issued it.

#### **GRAND REPRESENTATIVES**

This year I received no requests from a Companion desiring to be appointed a Grand Representative of one of our sister jurisdictions. Perusing the Grand Chapter's list of Grand Representatives, I see that there are almost fifty vacancies on the list. If there are any Companions who desire to serve as a Grand Representative, I urge them to contact the incoming Grand High Priest with their request.

One thing that I have noticed is that in some of the other jurisdictions an attempt has been made to have one Companion as the Grand Representative for both the Grand Chapter and Grand Council in a sister jurisdiction. As openings occur this arrangement should be considered for Connecticut

#### **OUT-OF-STATE VISITATIONS**

I have long held the opinion that when a Companion accepts a Grand line appointment he commits himself to two obligations; first, and foremost, to the in-state activities and secondly, to visits to sister jurisdictions. Of the two, the in-state activities are the more important. However, visitations to other states also have benefits. The amity created between the two jurisdictions is important and the friendships developed over the years are long-lasting. It is also interesting to learn of the concerns and difficulties of those other jurisdictions as well as observing different practices that could be incorporated to benefit our Chapters.

This year I was able to attend the Grand Chapter Sessions in six sister jurisdictions: Vermont, Massachusetts, New Jersey, Delaware, Maine and New Hampshire. The Rhode Island Session was held the same weekend as our Grand Lodge Session, and I had other Masonic and family conflicts preventing me from attending the Grand Sessions of New York, Pennsylvania and Maryland. I also attended the Ohio Grand Chapter session during an October visit to my family in Ohio. Since Lady A.J. spent most of the year rehabilitating her knees, I had to attend these sessions by myself. I was courteously received everywhere I went and thoroughly enjoyed these visits. I also attended ZOOM teleconferences of the General Grand Chapter, General Grand Council and the Easter Service of Grand Encampment.

In September, I attended the General Grand Chapter/Council portion of the Northeastern Department Conference at Albany, New York. This session was much different than the previous ones with

an emphasis on the benefits of General Grand Council as opposed to what awards they have to offer. I enjoyed an inspiring message from Most Excellent General Grand High Priest Steven Tiner and an excellent presentation on our charity, Royal Arch Research Assistance.

#### **IN-STATE VISITATIONS AND ACTIVITIES**

This year I was received and asked to address the Annual Grand Lodge Session, the Grand Court of Amaranth and the Order of the Eastern Star Grand Chapter Session. I marched with the Grand Chapter officers in the Grand Master's Day Parade and attended the Saint John's Day Worship Service at Holy Trinity National Polish Catholic Church. Family concerns prevented me from attending the Grand Assembly of Rainbow for Girls and the DeMolay Grand Conclave.

Over the year I attended 132 Masonic events, of which 58 were Chapter-related events. I had set a goal of making at least two visitations to each of the eleven Chapters. Unfortunately I was unable to make an official visit to either Rittenhouse Chapter 11 or Joseph Andrews-Pulaski Chapter 26 as they meet on the same night as my Cyrus-Meridian Chapter 15 does. I was able to attend the Summer York Rite awards picnic in Rittenhouse Chapter 11. In addition to attending my own two Chapters 19 times, I made 25 visitations to the other Chapters in Connecticut. I witnessed two excellent degrees; a Mark Master Mason Degree in Keystone 6 and a Royal Arch Degree in Pythagoras 17. At this degree the roles of Captain of the Host and Principal Sojourner were portrayed by two Companions who were working them for the first time.

#### AWARDS

I received no nominations for either the Ephraim Kirby Medal or the General Grand Chapter Metal in Bronze. This was unfortunate because the Ephraim Kirby Medal should be given as a recommendation of the Companions of a Chapter. Therefore the choice of the recipients fell to me. I chose to present the Ephraim

Kirby medal to Companion Gerald Alan Calibritto, the Right Excellent Grand Master of the 3<sup>rd</sup> Veil. It is my opinion that in addition to serving the Grand Chapter, he has been instrumental in seeing that the consolidation of Joseph Andrews Chapter 46 and Pulaski Chapter 26 has been successful.

I also chose to recommend Companion Gary David Shepard, Right Excellent Grand Royal Arch Captain, for the General Grand Chapter Medal in Bronze. I am pleased that my recommendation has been accepted. Right Excellent Companion Gary has been very visible in the Chapters this year making several visits to help Chapters to open meetings. I am certain as he continues to advance in the Grand Chapter line he will be a valuable asset for Capitular Masonry in Connecticut.

Both of these awards were presented at last night's banquet.

#### **FIFTY-YEAR PINS**

One of the privileges of a Grand High Priest is to present fifty-year service pins to qualified Companions. This year there were seven eligible Companions:

Most Excellent Companion Lott received his fifty-year pin at last year's Annual Convocation and sadly Companion Thomas died before his could be presented. Lady A. J. and I were able to visit his daughter to give her his pin. I was also able to visit with Companion Hair at his home for his presentation. Companions Paine and Pitcher

are both residents of nursing homes and due to state visitation regulations still in place I was not able to meet with them. Thus I mailed the other four certificates and pins to the Companions.

#### STATE OF CAPITULAR MASONRY IN CONNECTICUT

Just prior to my installation the consolidation of Franklin Chapter 2 and Halleck Chapter 44 into Franklin-Halleck Chapter 2 has left Connecticut with eleven Chapters and eleven Councils. Eight of these Chapter/Council combinations hold meetings backto-back on the same night and the other three meet on two separate nights. One of the Chapters still holds two meetings a month.

The geographical arrangement of the Chapters in Connecticut is also interesting. Two Chapters, Trinity 9 in North Windham and Union 7 in Norwich are on the Eastern side of the state. Two Chapters, Cyrus-Meridian 15 in Danbury and Rittenhouse 11 in Norwalk are on the Western side of the State. Three Chapters, Housatonic 13 in Stratford, Joseph Andrews – Pulaski 26 in West Haven and Franklin-Halleck 2 in New Haven are along the I-95 corridor, and three Chapters, Keystone 6 in Meriden, Pythagoras 17 in East Hartford and Washington 30 in Suffield are along I-91. And finally there is one outlier, Columbia 31 in Collinsville. With this arrangement most of the state is covered, but the loss of any of the four Chapters on the Eastern or Western side of the state would leave a large area without a Chapter.

Prior to the relocation of Cyrus-Meridian 15 and its associated Council, Buel 20, from Torrington to Danbury, there was no Chapter for the Brothers in the Northwest corner of the state. Last Month Cyrus-Meridian 15 exalted six Companions who probably would not have become Royal Arch Masons without the move. Already it has reaped benefits.

I would certainly like to be able to report that all eleven Chapters are active and thriving, but I cannot. In my opinion Keystone Chapter 6 is the strongest Chapter, and by combining the Chapter with Hamilton Council 9 and Saint Elmo Commandery 9, it makes Meriden the strongest York Rite center in Connecticut.

I believe there are four levels of Chapters in Connecticut. The top level is composed of the three strongest Chapters; Keystone 6, Rittenhouse 11 and Housatonic 13 who are more than capable of functioning by themselves.

The second level consists of four Chapters; Franklin-Halleck 2, Pythagoras 17, Joseph Andrews - Pulaski 26 and Columbia 31. The first three have a strong veteran base complimented by an influx of new Companions. Columbia 31 depends on their veteran members for their success. For the most part these four Chapters are able to function successfully, but there should be some level of oversight by the Grand Chapter to assure they continue to thrive.

The third tier has three Chapters; Union 7, Trinity 9 and Cyrus-Meridian 15. Union 7 has had a hard time recovering from the COVID shut down. Their ZOOM teleconferences during that period were outstanding, and they really connected with their out of state and home-bound Companions. However on returning to in-person meetings they lost that connection. They have tried to hold some hybrid meetings but this concept is hard to maintain. The Chapter appears to have a solid base of veterans, and they are trying to keep things going. A class of new candidates would do them well. Trinity 9 has had a hard time overcoming the passing of their Secretary, Right Excellent Companion Gary Littlefield. Their success is further complicated by the announcement that the replacement Secretary has recently retired and is moving to Texas. I believe this Chapter has a future, but needs encouragement to attain it. Cyrus-Meridian 15 has had to survive the move from Torrington to Danbury. The reason for this relocation was made necessary in 2022 when the Chapter was informed that the lease on the Masonic Temple building in Torrington would expire at the end of the year, and it would not be renewed. The Chapter was proactive in seeking a new home before the end of the year and relocated to Danbury in December. The building lease was actually extended after the Chapter had moved. This move resulted in the loss of several

Companions who either didn't accept the move or wouldn't travel to Danbury for meetings. However the six newly exalted Companions have all taken officer positions this year. The Chapter has also been invited to present York Rite instruction programs in several of the Lodges in Western Connecticut. It may take a couple of years but this Chapter will return to prominence.

That leaves one Chapter, Washington 30 at the fourth level. This Chapter is still able to open with some assistance and even has a relatively new High Priest. However they have not exemplified any of the degrees for several years and have had only one exaltation in the last four years. Their old-line Companions are trying to keep the Chapter going, but the lack of new Companions is making this difficult. It is probably time to consider a consolidation, possibly with Pythagoras Chapter 17.

#### **RECOMMENDATIONS**

Therefore, I have some recommendations for consideration:

1) That the Grand High Priest continues to monitor the status of Washington Chapter 30 and if necessary guide them to a consolidation with another Chapter.

2) That the Grand High Priest continue to encourage his Grand Officers to help Union Chapter 7 and Trinity Chapter 9 to continue to move toward self-sufficiency.

3) That the Grand Officers continue the excellent work that they did this year. Making visits to Chapters is important so that the officers can see the problems of each Chapter.

#### THANK YOUS

In closing, I would like to give my thank you's to a few Companions.

<u>Bruce R. ## **GRAND SECRETARY**

Companions all. I am more than pleased to be back at my station this year and present my report in person, after my hiatus last year for my daughter's wedding, and with Assistant Secretary, ME Charles Fowler sitting in, to whom goes my deepest appreciation. And my gratitude doesn't stop there, as he continues to keep our database up to date and secure while we continue to transition files and records. This has afforded me more time to respond to phone and email inquiries, especially helping our new secretaries settle into their duties. On our team this year, ME James McNeely has been the liaison with the Royal Arch Magazine that goes to all Companions, RE Michael Sabia has taken on the monthly collection of Opportunities, and a shout-out to SecRec Ray Knieriem in the "Quiet Corner", my "go to" software guru.

Compared to last year's efforts to recover from COVID, it would seem we're almost there, but having peeled back the curtain of uncertainty, we see our strong Chapters returning to their pre-

COVID levels of activity and even flourishing, while our weaker Chapters are still struggling. There have been some bright spots. The physical move of Cyrus Meridian 15 back to their homestead in Danbury has reinvigorated interest in the York Rite in that region; Keystone 6 is now refueled in Meriden with Washington - Burning Bush Companions and is prosperous. And we have seen a surge in new Companions in the Stratford- Darien corridor. But not all the news is good: the merger of Halleck Chapter with Franklin Chapter in New Haven after a year, still has a way to go. And when taken together across the board, we still continue to show a net loss for the year. Go figure.

**Legacy Jewels.** Of my two campaigns last year, the Legacy Jewel Program for our aged Past Grands to create a living memorial - carried by a younger Past Grand, is beginning to bear a little fruit, but still has a long way to go. The need to preserve our lineage is never more shown than by the loss of 5 our York Rite Past Grands in just a two month span last winter.

**Succession Planning,** Another barometer of our future, is also becoming more elusive and difficult as our numbers decrease and young officers are harder and harder to find, and train.

Currently we are settling into 2 year terms for our sitting HPs, with some PHPs stepping back into the rotation from the retired ranks, and we have a couple bodies where the HP and TIM are the same – double duty. The tougher group to replace is those retiring Companions who have served decades as both the Secretary and Recorder. We are excited that we have 3 who were new last year and now are veterans, and another 2 fresh on this year already learning the ropes with the Annual Returns: Scott Atkins down in New Haven, and Art Carbonaro up in the Quiet Corner, stepping in for Ray Knieriem who is retiring and relocating out of state. But for the smaller groups, and fewer Companions to draw from, more and more consideration is being given to combining the Sec/Rec job with the Treasurer's, not unique these days, but one that requires

added controls and approval of the Companions. And of course, we still hear of old Treasurer accounts being locked when prime account holders leave us though we're making progress there as well.

**Recruit From Within.** We have always viewed, and continue to view, our Blue Lodges as the target rich environments for recruiting new Companions. But we have another pool we seldom if ever think about, and that is the category of Dimits and NPDs seemingly lost to us forever. The numbers tell the story (see the accompanying table). In the last decade and excluding death, Dimits and NPDs account for 70% of our losses and EXCEED the number of new Companions for whom we expend an awful lot of time and resources recruiting. On occasion a few do re-up on their own, but if we can be more pro-active in re-opening communications with our NPDs and Dimits, we stand not only to regain their experience and skill sets but spend less effort in doing so. In essence we would actually be "recruiting from within". This is not to say we don't pursue the Lodges, but we can explore CT possibles as a start. We're not going to get them all back, and it is not free, but among the more recent losses especially during COVID, there is some sentiment for a return to Masonry. Using our internal data bases, and by starting with the Chapters, we can explore those we can approach. Then the Councils, and even non-affiliated Templars and who knows, and the AASR and Shrine too that have Yorkies on their roles! A little like shopping for low mileage used cars that can still be appreciated. In fact, I would hazard a guess that EVERY Companion out there knows at least ONE former Companion-Brother (out of the decade's pool of 700 or so) he could talk to about coming back into the York Rite.

**Financials on the Year.** I find that working alongside Grand Treasurer Charles McCollum continues to be a seamless activity as it should be, even fun at times. As my bookend, he received this year \$ 15,000 from the Trustees, and from me, \$25,688.08 in receipts deposited for the fiscal year ending April 30, 2023. On the expense side, I issued vouchers totaling \$ 38,323.08 for payment of

regular budget obligations. It is noteworthy that this year was our first return to a full-service budget after the COVID, and the tally for the Grand Session was comparable to 2019 and prior years: for the invited guests and hospitality, the net cost to the Chapter ended up being \$3694 and the Council \$3423, difference attributed to the different number of sleeping guests. And this is after all proceeds and upfront costs were borne by the Grand Chapter with the Grand Council reimbursing their share. So we're back in business, and have a new home, the Cromwell Marriott!

In closing, it has been an honor to be of continuing service to the Grand Chapter, and with your continued support, guidance and inspiration, we are always moving forward in service to all our Companions.

This is not to say that the Chapter lacks strong ritualists. There a several strong ritualists within this Chapter.

The Chapter was inspected on all points except degree work. Unfortunately, they did not have any candidates to see a degree at the time of the inspection. #### **GRAND HISTORIAN**

Greetings Companions,

As I discussed in my Grand Council Historian report, as we return to our usual busy Masonic schedules we should be looking at our history afresh. Many lodges are having work days to clear out the cobwebs of the last two years. As Companions, we should be there helping so that our history does not go amiss. Some brothers make assumptions that nobody knows what that is or that nobody cares about a history that they themselves have not taken time to

learn. We need to be present, as "well-informed brethren", to not only protect our history but to educate our non-York Rite brothers on the benefits of Chapter and Council. Numbers of Master Masons may be declining in the state, but there are still literally thousands who have not been shown the knowledge and philosophy that we have to offer in Capitular and Cryptic Masonry.

If we look at our early history, we can see that York Rite degrees were considered essential even before our Grand Bodies were formed. In looking at New Haven in the 1790s, Hiram Lodge #1 was essentially three lodges: The Lodge at New Haven/Hiram (conferring the first two degrees, The Master's Lodge (conferring the third degree) and The Mark Masters Lodge (conferring at least the Mark degree, later becoming Franklin Chapter). Other Chapters formed this way, as is still common in England, out of lodge brothers seeking further light in Freemasonry. These brothers laid the foundation for our York Rite. We owe it to them to make sure that our individual Chapter's history is not lost. Do not forget, your Grand Chapter officers are here to help and I as Grand Historian more so. Do not hesitate to ask any questions you may have or how to preserve your history.

As noted in the Mark Master Charge: "The situation to which you are now promoted will draw upon you, not only the scrutinizing eyes of the world at large, but also of your brethren on whom this degree of Masonry has not been conferred; all will be justified in expecting your conduct and behavior to be such as may with safety be imitated". Also from the Most Excellent Master: "It is one of your duties, as a Most Excellent Master, to dispense light and truth to the uninformed Mason; and I need not remind you of the impossibility of complying with this Obligation without possessing an accurate acquaintance with the lectures of each degree". And finally, a reflective reading of your Obligation as a Royal Arch Mason is strongly encouraged.

### **COMMITTEE ON INSURANCE**

Your Committee on Insurance wishes to report that in May and June of 2022, this time last year, our senior Chairman for our collective York Rite Insurance for many years, MEPGHP Robert Fitzgerald was actively and successfully negotiating new policies for our benefit. There are two parts to our coverage: an Umbrella policy for all our York Rite based on our distribution of members around the state, and a Liability policy for our Grand Officers. Careful examination of our Umbrella coverage revealed a rider for our members when they attend meetings using a rental car, not a frequent nor even likely occurrence, and elimination of this risk as well as other corrections, resulted in an almost 30% reduction in our shared premium. The Liability policy was also structured for a 3year fixed rate, with a small but realizable savings as well. Renewals of coverages and rates are anticipated for this June for comparable premiums.

But while ME Bob was continuing to move into full retirement, all our York Rite was surprised to learn that in January of this year,

as the result of an unexpected illness, the GAU called ME Bob to that far distant country from whence he will never return. The Committee mourns his loss and yet embraces his legacy of knowledge and hard work left behind for us to build upon. His life of service can be found in the Necrology Report of our proceedings.

# GENERAL GRAND CHAPTER DISTINGUISHED SERVICE MEDAL IN GOLD

The General Grand Chapter Distinguished Service Medal in Gold is presented by the General Grand Chapter for extraordinary Masonic achievement and/or national or international achievement in the Arts and Sciences, in Public Service, or in Business and the Learned Professions. Not more than one medal may be presented each year.

The only Connecticut recipient of this highest of honors was Companion James R. Case (9), now deceased, who received the medal in 1988.

# GENERAL GRAND CHAPTER DISTINGUISHED SERVICE MEDAL IN SILVER

The General Grand Chapter Distinguished Service Medal in Silver is presented for exceptional Masonic achievement; the performance of outstanding service for the York Rite, but particularly for Royal Arch Masonry. Nominations may be made by the Grand High Priest and forwarded by the D.G.G.H.P. and by him to the General Grand High Priest. Nominations shall be accompanied by a resume of the Royal Arch Service of the proposed recipient and a brief biographical statement. Three nominations may be made during a Triennium from each jurisdiction, but only one will be presented during each Triennium to a Royal Arch Mason of one of the affiliated Grand Jurisdictions of each York Rite Region. Not More than three such Silver Medals also may be presented at the Triennial Convocation from selection at large.

Only three Connecticut Companions have been recipients of this very high honor:

Companion Richard L. Smail (18,27), now deceased, who received the medal in 1991.

Companion Charles B. Fowler, Jr. (17), who received the medal in 2011.

Companion James S. McNeely, IV (17), who received the medal in 2020.

# GARY DEAN SHEPARD General Grand Chapter RAM Intl Bronze Medal Award

Gary Dean Shepard was born on October 20, 1952, in St. Albans, Vermont. His father was Harley G. Shepard, MD of Burlington, VT, and his mother, Adelaide (Parent) Shepard, was from Richmond, VT. Shortly after being born, his father moved the family from St. Albans to Bristol, VT where his father began practicing medicine. By the time Gary was five years old, his father decided to leave his private practice to enter occupational medicine. The family moved to Bridgewater, NJ where Gary and his four other brothers grew up. He graduated from Bridgewater-Raritan High School in 1970. He went back to his native Vermont roots to attend the University of Vermont where he studied zoology and graduated in 1974.

During those years in New Jersey, Gary developed a few different interests. From his mother, he became interested in music. To begin with, he took piano lessons for a couple of years. In the fourth grade he took up the trumpet, which was more to his liking, and played it through high school. He was involved in the orchestra, the concert band, the marching band, and the dance band.

Gary was active in the Boy Scout program beginning as a Cub Scout, progressing until he, and his four brothers, became Eagle Scouts. Gary became a member of the Order of the Arrow, and he was also invited to the BSA National Camp School, which then qualified him to be a waterfront director for the 1977 national jamboree in Idaho.

Gary learned to swim at a young age, and competitive swimming soon became a large part of his life. Gary earned three varsity letters at the high school level and four at University of Vermont. He became a lifeguard and was also involved in teaching swimming

lessons to younger children. The most satisfying experience for Gary, however, was in coaching competitive swimmers.

Although Gary grew up in New Jersey, he started his professional career in Boston in 1977, and he still considers Boston his home. He started as a pharmaceutical sales representative for Geigy Pharmaceuticals. During his travels throughout Boston, eastern Massachusetts, and southern New Hampshire, Gary met a lovely young lady, Janet Casale, with a beautiful smile from Brighton, Massachusetts. They were married four years later. They bought a small parcel of land in Brookline NH and built a home on it where they lived for six years. During that time, their daughter, Lauren Elizabeth, was born.

Gary began expressing interest in becoming a Mason around the age of nineteen. After graduating from college and becoming eligible to join, his plate was full with other activities and interests. It wasn't until he was 43 and had relocated to Connecticut that he suddenly realized that he had not become a Mason yet.

He finally petitioned Ashlar Aspetuck Lodge No. 142, and his Masonic career began on September 18, 1995 when he was initiated as an Entered Apprentice. On November 8, 1995, he was raised to the sublime degree of a Master Mason, and was soon asked if he wanted to join the officer line. Five years later, in 2000, Gary became Worshipful Master. In 2016 Gary affiliated with Daytime Lodge No. 144 and served as Worshipful Master in 2017. Throughout his Masonic career, he served in other positions where needed.

Gary became a Scottish Rite Mason in the Valley of Bridgeport in 1997. In addition to completing four Passports, he has also taken part as a cast member in most of the degrees. He was Thrice Potent Master of Dewitt Clinton Lodge of Perfection, Sovereign Prince of Washington Council Princes of Jerusalem, and Most Wise Master of Pequonnock Chapter of Rose Croix. He was honored to receive the Illustrious Arthur M. Brown, 33<sup>rd</sup>, Meritorious Service Award at the 2007 annual meeting. From 2006 to 2022, Gary served on the Valley of Bridgeport Executive Committee. He was Chairman of

the Family Life Committee from 2013 to 2022 where he helped organize over a hundred fellowship programs for the Valley and Consistory. Currently, Gary is on the Valley of Bridgeport Colonial Fellow Craft Degree team that performs the FC degree for blue lodges in Connecticut.

In December 2010, Companion Gary was exalted as a Royal Arch Mason in Baldwin Chapter No. 13 in Stratford, CT. In 2016 he was elected Excellent High Priest. He received the Order of High Priesthood that same year from the Connecticut Convention of Anointed High Priests. When Baldwin Chapter merged with Milford Chapter to become Housatonic Chapter No. 13, Gary was on the committee which implemented the plan that saw a very successful merger of two Chapters into a new and better Chapter. In 2019, Most Excellent Grand High Priest James C. Kleinkauf appointed Gary as Grand Sentinel of the Grand Chapter of Royal Arch Masons of Connecticut. He currently serves as Grand Principal Sojourner and as chairman of the Grand Chapter Audit Committee.

Gary is also a member of Mohawk Council No. 28, Knight Masons; Connecticut York Rite College No. 17; Connecticut Priory No. 28 of the Knights of the York Cross of Honour; and Monker Grotto M.O.V.P.E.R.

On June 14, 1997, Gary became a Shriner in Pyramid Temple, A.A.O.N.M.S. He was a member of the Omar Shrine Club and is currently a member of the Legion of Honor. In 2017, he was elected to Dimaryp Court of the Royal Order of Jesters.

Gary was greeted as a Select Master in Jerusalem Council No. 16 in early 2011. He advanced through the officer line and served as Thrice Illustrious Master in 2016, when he also received the Order of the Silver Trowel. Currently he is serving as TIM in Paugussett Council No. 16.

Gary was knighted on Good Friday of 2011 in Hamilton Commandery No. 5. He was installed as Eminent Commander and

served from 2017 to 2019. Gary became a Knight Crusader of the Cross shortly after he was installed as Commander, and currently serves as Knight Crusader of the West.

### EPHRAIM KIRBY CITATION FOR DISTINGUISHED MASONIC SERVICE

The Ephraim Kirby Citation was established in 1944 to recognize and show appreciation to the Companion who is outstanding in his Masonry, his community and his daily vocation and who has an unusual record of loyalty, perseverance, dependability and/or courage. It is not meant to be given to those who have already received honors, but is especially intended for those who are so unselfishly devoting time and zeal to the welfare of individual Chapters and Masonry that they may be classed as the forgotten Companion. The Ephraim Kirby Citation is to ensure that such merit does not go unrewarded.

The Judges for the Citation are the Committee on Awards of the Grand Chapter. A Candidate for the Citation must be a Companion in good standing and shall not have applied himself for the Citation. Any Chapter may recommend a candidate for the Citation and the decision of the judges will be considered final. No more than one Citation for each thousand members of fraction thereof may be awarded in any one year. It should be emphasized that the award was set up to be awarded those Companions who had served their Chapters and had never been High Priest.

The Ephraim Kirby Citation for Meritorious Service is awarded for:

- Real loyalty and exceptional service to Masonry, particularly the Capitular degrees.
- Rendering, without the hope of fee or reward, unusual and outstanding service to his community, state, or nation.
- Having performed an act of heroism.

The award consists of a certificate or citation of meritorious service together with a suitable emblem of same and is presented at the Annual Convocation of the Grand Chapter or other suitable

#### MICHAEL EUGENE SEAMON

Michael Eugene Seamon was born in 1956 to Frederick and Clara Seamon, in Hartford, CT. Mike is one of 4 boys, his brother Timothy resides with his family in North Carolina, his brother Stephen lives in New Hampshire with his wife, and his brother David resides in Moodus, CT. Mike discovered and met His older half-brother John Jacko and Linda Jacko, his half-sister in 2018.
